Reiki Tradition School of Reiki:

Membership & Practice Policy (2026)

1. Membership Eligibility & Tiers

To maintain the highest standards of energetic integrity, membership is categorised into the following levels:

- **Follower Member:** Free Member: Free 1 year membership: (We would like to have you onboard, see what you are missing. And take advantage, of our great opportunity on course Incentives available.) (£0 First Year) after First year a paid option will be required.
- **Animal Member:** Must hold a minimum of Reiki Level 2 certification. Training must include attendance and completion of our 'Pawsome World of Reiki for Animals Accredited Reiki Course.'
- **Student Member:** Must provide a verified lineage chart tracing back to Mikao Usui 1st generation. Be able to demonstrate a minimum of one year of active practice at Level 2. Must have been trained under the supervision of a Master Teacher. Hold Public Liability and Indemnity insurance and be able to produce Continuing Professional Development (CPD) Points.
- **Full Member:** Must provide a verified lineage chart tracing back to Mikao Usui, 1st Generation. Currently enrolled in or on, a Reiki Tradition course or has undergone face to face training (Level 1, 2 or 3rd Degree). Must have been trained under the supervision of a Master Teacher. Hold Public Liability and Indemnity insurance and be able to produce Continuing Professional Development (CPD) Points.

2. Standards of Training (In-Person Mandate)

Reiki Tradition adheres to the traditional requirement that all attunements and initiations be conducted **in-person**.

- Members certified through the school must attend physical workshops to ensure the correct transmission of energy and hand placements.
- Annual Continuing Professional Development (CPD) is encouraged to maintain membership, involving a minimum of 10 hours of Reiki-related learning or retreat participation. CPD can be recognised as Points or Hours

3. Code of Ethics & Professional Conduct

All members of the Reiki Tradition School of Reiki must sign and uphold the following ethical mandates:

- **Non-Diagnostic Clause:** Practitioners shall never diagnose medical conditions, perform manipulations, or interfere with a client's prescribed medical regimen.
- **Confidentiality:** All client records and session details must be kept strictly confidential in accordance with GDPR and Data Protection acts.
- **Informed Consent:** Practitioners must explain the Reiki process clearly and obtain written or verbal consent before any session begins.
- **Professional Boundaries:** Practitioners must maintain a professional environment and refrain from any conduct that could be construed as sexual, exploitative, or coercive.

4. Insurance & Legal Compliance

- **Professional Indemnity:** All Professional Practitioner and Master-level members must hold active **Professional Indemnity and Public Liability Insurance**.
- **Health & Safety:** Members operating a physical practice must ensure their premises meet local health and safety regulations, including fire safety, hygiene standards, and Risk Assessments.

- **Disclosure:** Members must disclose any criminal convictions or disciplinary actions taken against them by other professional bodies.

5. Session Protocols

- **The Five Principles:** Members are expected to integrate the Reiki Principles (Gokai) into their daily lives and practice.
- **Client Comfort:** Clients remain fully clothed (except for footwear) during sessions. Practitioners must ask permission before placing hands on specific areas of the body.
- **Right to Refuse:** A practitioner has the right to refuse treatment if they feel the situation is unsafe or if the client's needs are outside their scope of practice (e.g., severe psychiatric crisis requiring clinical intervention).
- **Client Information Form:** Members are required to integrate Consultation Sessions with every new client. Every form must be stored securely and safely in compliance with GDPR Requirements.
- **Aftercare:** Members are required to work in a professional manner giving out Client Aftercare Sheets. Engage with clients after every treatment, ensuring clients fully understand any feelings, sensations after a Reiki treatment. Hand them a Client Aftercare sheet.

6. Membership Fees & Renewals

- **Annual Dues:** Membership is renewed every 12 months. Failure to renew within 30 days of the expiration date will result in removal from the School's Accredited Practitioner Directory.
- **Termination:** The Reiki Tradition School reserves the right to revoke membership if a member is found in breach of the Code of Ethics or if their actions bring the tradition into disrepute.
